Figure 2-1A. Lifetime Substance Use by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 2-1B. Lifetime Substance Use by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 2-1C. Trends in Lifetime Substance Use, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 2-1D. Lifetime Substance Use at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 2-2A. Current Substance Use* by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 2-2B. Current Substance Use* by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 2-2C. Trends in Current Substance Use*, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 2-2D. Current Substance Use* at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 2-3 Access to Tobacco*, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 2-4A. Alcohol Use* by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 2-4B. Alcohol Use* by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 2-4C. Trends in Alcohol Use*, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 2-4D. Alcohol Use* at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 2-5 Access to Alcohol Among Current Drinkers*, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 2-6A. Marijuana Use by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 2-6B. Marijuana Use by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 2-6C. Trends in Marijuana Use, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 2-6D. Marijuana Use at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 3-1A. Fighting and Weapon Carrying by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 3-1B. Fighting and Weapon Carrying by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 3-1C. Trends in Fighting and Weapon Carrying, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 3-1D. Fighting and Weapon Carrying at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 3-2A. Bullying by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 3-2B. Bullying by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 3-2C. Trends in Bullying, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 3-2D. Bullying at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 3-3A. School Bullying* Bystander Behaviors by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 3-3B. School Bullying* Bystander Behaviors by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 3-3C. Trends in School Bullying* Bystander Behaviors, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 3-3D. School Bullying* Bystander Behaviors at the District and Regional Levels, 2012




Figure 3-4A. Cyberbullying* Bystander Behaviors by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 3-4B. Cyberbullying* Bystander Behaviors by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 3-4C. Trends in Cyberbullying* Bystander Behaviors, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 3-4D. Cyberbullying* Bystander Behaviors at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 4-1A. Behaviors Related to Unintentional Injury by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 4-1B. Behaviors Related to Unintentional Injury by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 4-1C. Trends in Behaviors Related to Unintentional Injury, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 4-1D. Behaviors Related to Unintentional Injury at the District and Regional Levels, 2012
Wilson Middle School, Natick (Grades 7-8)




Figure 5-1A. Mental Health and Suicidality by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 5-1B. Mental Health and Suicidality by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 5-1C. Trends in Mental Health and Suicidality, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 5-1D. Mental Health and Suicidality at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 6-1A. Weight Perception and Body Weight by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 6-1B. Weight Perception and Body Weight by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 6-1C. Trends in Weight Perception and Body Weight, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 6-1D. Weight Perception and Body Weight at the District and Regional Levels, 2012
Wilson Middle School, Natick (Grades 7-8)




Figure 6-2A. Physical Activity by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 6-2B. Physical Activity by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 6-2C. Trends in Physical Activity, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 6-2D. Physical Activity at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 6-3A. Nutrition* by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 6-3B. Nutrition* by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 6-3C. Trends in Nutrition*, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 6-3D. Nutrition* at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 7-1A. School Attachment by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 7-1B. School Attachment by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 7-1C. Trends in School Attachment, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 7-1D. School Attachment at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 7-2A. Adult Support by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 7-2B. Adult Support by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 7-2C. Trends in Adult Support, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 7-2D. Adult Support at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 7-3A. Peer Support by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 7-3B. Peer Support by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 7-3C. Trends in Peer Support, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 7-3D. Peer Support at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 7-4A. Bullying* and Adult Support by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 7-4B. Bullying* and Adult Support by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 7-4C. Trends in Bullying* and Adult Support, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 7-4D. Bullying* and Adult Support at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 7-5A. Cyberbullying* and Adult Support by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 7-5B. Cyberbullying* and Adult Support by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 7-5C. Trends in Cyberbullying* and Adult Support, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 7-5D. Cyberbullying* and Adult Support at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 7-6A. Mental Health and Adult Support by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 7-6B. Mental Health and Adult Support by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 7-6C. Mental Health and Adult Support, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 7-6D. Mental Health and Adult Support at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 8-1A. Substance Use on School Property by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 8-1B. Substance Use on School Property by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 8-1C. Trends in Substance Use on School Property, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 8-1D. Substance Use on School Property at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)




Figure 8-2A. Violence and Bullying* on School Property by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 8-2B. Violence and Bullying* on School Property by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




Figure 8-2C. Trends in Violence and Bullying* on School Property, 2008-2012 Wilson Middle School, Natick (Grades 7-8)




Figure 8-2D. Violence and Bullying* on School Property at the District and Regional Levels, 2012 Wilson Middle School, Natick (Grades 7-8)






Figure 8-3A. Locations of Bullying* on School Property by Gender, 2012 Wilson Middle School, Natick (Grades 6-8)





Figure 8-3B. Locations of Bullying* on School Property by Grade, 2012 Wilson Middle School, Natick (Grades 6-8)




