In follow up to our conversation yesterday:

The District needs a letter stating it is authorized to add its share of bid savings on the KMS project to the construction contingency line item of the KMS project budget.

The District would transfer up the same percentage as its current projected share of total project cost. So 51.79% of the \$8,449,500 in "bid savings" which totals \$4,376,043.

This amount would be added to the project's construction contingency line item. This added amount will be ineligible for reimbursement from the MSBA.
